Great Plains Cooperative Ecosystem Studies Unit 2023 Annual Report



Director's Report

2023 was a very productive year for the Great Plains CESU, and as always, the year held several changes to our operation. Importantly, the Great Plains CESU staff decided to switch our annual meeting from November to January. The change allows us to better reflect on the year and provide more accurate budget and grant dollar amounts that were awarded through the network. We also held our first hybrid GP CESU Annual Meeting since prior to the COVID-19 pandemic. See more about our meeting and partner engagement below. The CESU program also held its first in person National Network meeting since 2019. The CESU Regional Directors, Federal Partners and others assembled at the National Conservation Training Center in Shepherdstown, West Virginia to update the group on recent activities and the future direction of our programs. This past year we had ~\$5.8 million in new agreements funded and ~\$23.2 million in modifications to agreements funded through the Great Plains CESU. Details on the projects funded from the past year are below.

Engaging Partners

The Great Plains CESU hosted our 2023 Annual Partners Meeting on January 18, 2024, as a hybrid meeting in which we engaged our partners locally and across the Great Plains. In typical fashion our agenda covered our review of the past year in our program, our recent activities and the discussion of some goals we have set for the future. We included remarks from Tom Fish from the national Cooperative Ecosystem Studies Unit office and representatives from many of our federal partners. We also included research talks from Jesse Bolli (NPS), Dr. Nancy Barth (USGS), and Dr. George Limpert and Dr. Dan Uden, both at the University of Nebraska-Lincoln. As always, we would like to thank our federal and academic partners who participated and provided discussion at the meeting.
